IMPORTANT INFORMATION

DURATION

This qualification is typically delivered 2 days per week over a minimum duration of 8 1/4 months, including 120 hours of work placement in an aged care facility.

DELIVERY

The training is conducted by a qualified, industry current, trainer and assessor to ensure the learning is relevant and up to date. This training will take place in a classroom environment using face-to-face training methods at one of our study locations. Intakes are scheduled throughout the year.

ENTRY REQUIREMENTS

There are no formal entry requirements for this qualification, although applicants will need to undertake an LLN assessment. Students are required to complete Practical Placement which requires a police clearance. Students must also have current COVID-19 and Influenza vaccinations.
